Bernards Township Parks & Recreation 4th Annual Community Art Show

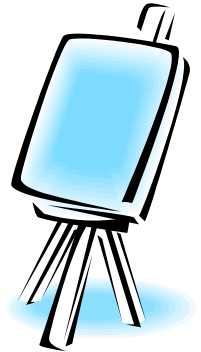

Entry Rules

- This is a non-juried art exhibit.
- Artists must be age 18 or older and a resident of Bernards Township.
- Artists may list up to 4 potential pieces for display. Each artist is guaranteed to exhibit two pieces. *If space permits, artists will be contacted should they wish to submit additional pieces.*
- Artwork previously entered may not be submitted for this show.
- Artwork can include, but is not limited to, watercolors, oils, acrylics, photography, pastels, drawings, mixed media, and sculpture.
- Hanging artwork must be dry, wired and ready for hanging on drop off day. Frames should be sturdy and plexiglass is preferred over glass. Size limit per piece is approximately 32" x 40", framed.
- If you are submitting 3D artwork, you must provide your own stand.
- Artwork must be family friendly. The Parks & Recreation Department reserves the right to reject artwork for any reason.
- You may indicate your artwork is for sale on the Entry Form. Visitors will be given the contact information you provide, should they be interested in purchasing artwork. The Township will not arrange sales.

There will be a \$250 deductible for each item.** The County of Somerset and the Somerset County Park Commission Environmental Education Center will not be responsible for any artwork left on the premises after 48 hours following the scheduled closing date of the exhibition.
